Graduate Employment Information: The program employment rate is the percentage of students who graduated between September 1, 2014, and August 31, 2015, and became employed in the Licensed Practical and Licensed Vocational Nurses Occupation. Out of a total number of 24 students that graduated in the cohorts enrolled between September 1, 2014 and August 31, 2015, 17 graduates (89%) got employed within 175% of program length as reported to the accrediting agency (ACCSC).
