

## CARES ACT/HEERF Grant Information

On April 9, 2020, the U.S. Department of Education (USDE) announced the availability of funds in the form of Emergency Grants that postsecondary institutions participating in the U.S. Title IV program can apply for and receive funds to be used for expenses related to the disruption of campus operations due to COVID-19 Pandemic. The USDE required that 50 percent of Emergency Grant must be distributed to eligible students impacted by COVID-19 Pandemic. Specifically, the purpose of the student allocation of the Emergency Grant is to provide emergency financial relief to eligible students "...for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care)." This grant was made available through the Coronavirus Aid, Relief, and Economic Security ACT/High Education Emergency Relief Fund (CARES ACT/HEERF).

Consistent with USDE's CARES ACT/HEERF program compliance requirements, Harmony Health Care Institute (HHCI) hereby provides the following required information:

1. HHCI acknowledges that it has signed and returned to the U.S. Department of Education the Certification and Agreement and the assurance that the institution intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. The total amount of CARES ACT/HEERF that HHCI has received from the U.S. Department of Education pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$45,928.
3. The total amount of Emergency Financial Aid Grants distributed to eligible students under Section 18004(a)(1) of the CARES Act as of June 19, 2020 is \$45,928.
4. The total number of students at HHCI eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 54 students.
5. The total number of eligible students at HHCI who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is 54 students.
6. The method used by HHCI to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act is presented below:
  - a. HHCI established a detailed CARES Act Emergency Financial Aid Grants Implementation Plan to guide the school in the implementation of the Program,

including the grant eligibility criteria, award amount determination formula, the responsible school personnel assigned to handle specific action items, and general oversight of the implementation plan.

- b. Consistent with the available USDE guidelines, HHCI established and used CARES ACT/HEERF eligibility criteria included as follows:
  - i. Students must have successfully completed the 2019-2020 FAFSA and have met the Title IV program eligibility criteria (as stipulated under Section 484) as of March 13, 2020.
  - ii. Student must be enrolled in the Licensed Practical Nurse (LPN) program prior to March 13, 2020 and actively attending by the CARES ACT/HEERF grant award date of May 18, 2020.
  - iii. Students must be determined as meeting the established HHCI-LPN program’s Satisfactory Academic Progress (SAP) requirements of greater/equal to 2.0 GPA and 67% attendance.
- c. To determine how much each eligible student would receive HHCI adopted a formula that used Expected Family Contribution (EFC). Please see the table below, which shows the formula HHCI used to determine the award amount per eligible student.

- 7. To ensure that each student at HHCI who is eligible for the Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act is fully informed about the Emergency Financial Aid Grants implemented the following strategies:
  - a. CARES ACT Emergency Financial Aid Grants – Student Notification Letter was created and provided to each student via email and/or in person. This letter informs the student about the Emergency Financial Aid Grant and its purpose, eligibility criteria used, the process for receiving the award, and the designated school personnel for responding to students’ questions and processing the grant award. A copy of the CARES ACT Emergency Financial Aid Grants – Student Notification Letter was also conspicuously posted on the designated “Student

Notice Board” on HHCI campus. Please see **Attachment A** for a copy of the CARES ACT Emergency Financial Aid Grants – Student Notification Letter.

- b. A CARES ACT Emergency Financial Aid Grants – Student Acknowledgement Form (which indicates the grant amount awarded and what the grant could be used for) was created and use for the distribution of the Grant Award check payments to eligible students. Please note that you will be required to sign the CARES ACT/HEERF Grant Acknowledgement Form and return to the school's Financial Aid Office at the time of receiving the grant check payment. Please note that this CARES ACT/HEERF Grant is not part of the Federal Student Loan program and does **not** need to be repaid.
